A false alarm is an alarm caused by customer negligence, equipment failure, animals, moisture, dust, temperature changes, unlocked entrances (windows or other openings), or other reasons attributable to the customer. In addition, a dispatch due to false alarm is also a recurrent dispatch, the reason for which has repeatedly remained unexplained and/or where the customer has not ordered a technician for equipment repairs and/or the contact person of the customer consistently failed to visit the premises to find out the reason for the alarm

- \* Calling a technician, a Handyman or a technical engineer is subject to a fee even if the technician arrives on the site but cannot do the necessary work due to reasons attributable to the customer.
- \*\* The fee of the technician, the Handyman or the technical engineer includes transportation from the nearest Forus office to a site within a 20km radius and up to one hour of working time. Working time is calculated in half-hour increments for each subsequent hour worked.
- \*\*\* The prices for the technician, the Handyman or the technical engineer apply on work days from 9.00 a.m. until 5.00 p.m. For services provided outside this period, the fee indicated in the price list is multiplied by 1.5. During national holidays, the fees in the price list are multiplied by 3. The fees do not include expenses related to equipment, materials or specialised tools etc.
